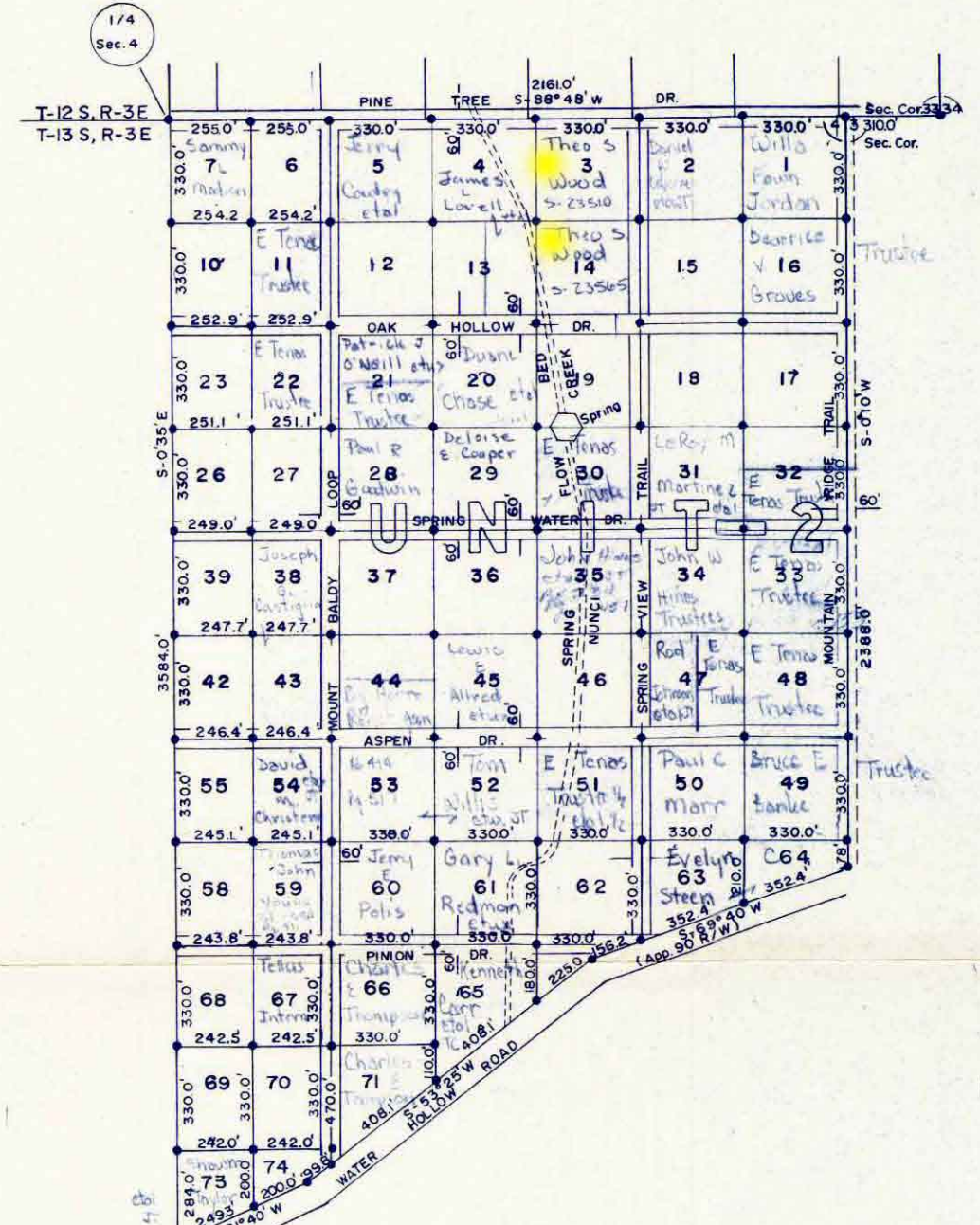
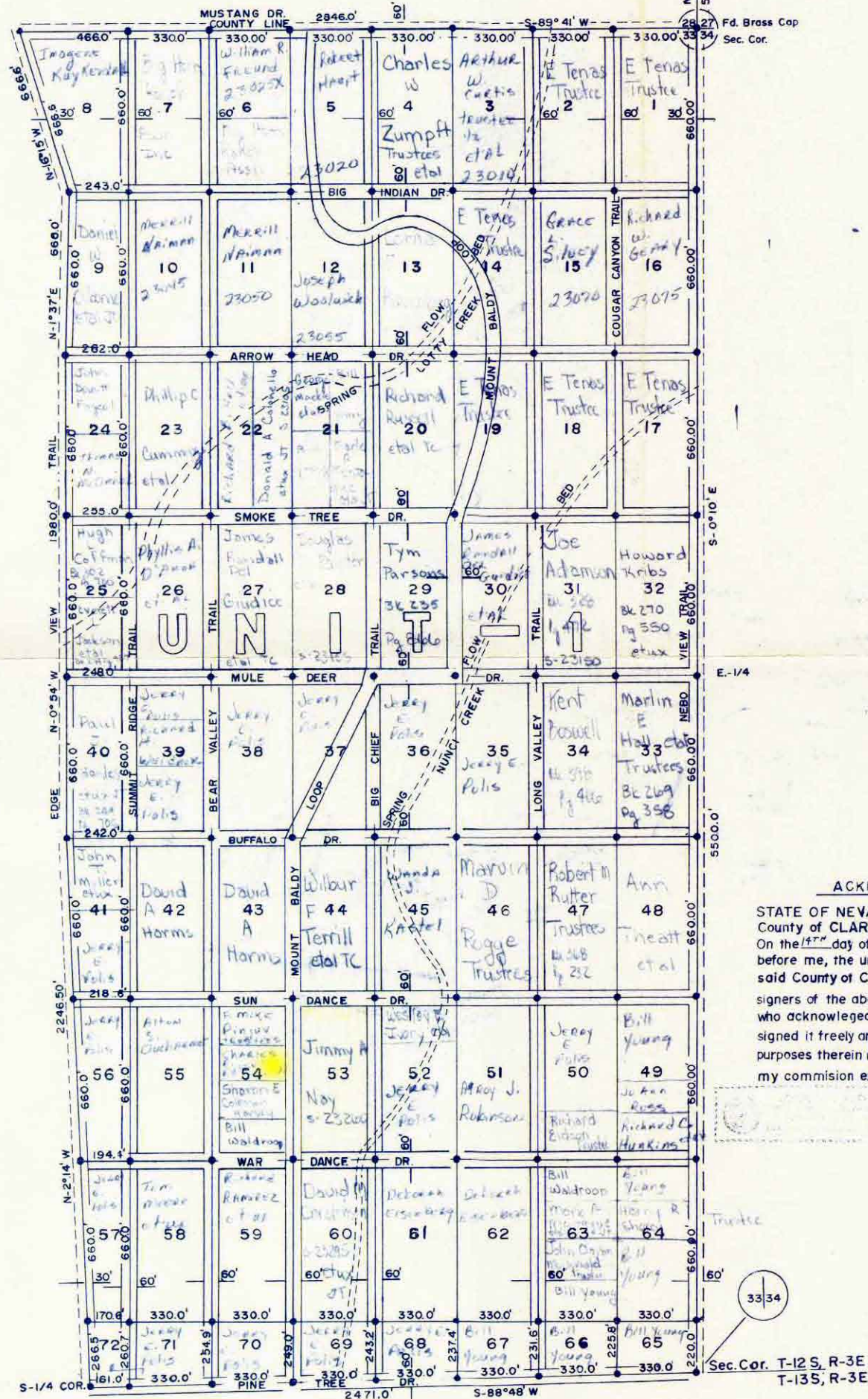

Cor., Sec. 33, T-12, R-3E, as the true pt. of Beg. - Thence S-0°10'E, 5500.0' to a point, Thence S-89°41'W, 2737.0' to a point, Thence N-10°15'W, 666.6' to a point, Thence N-01°37', 660.0' to a point, Thence N-0°54'W, 1980.0' to a point, Thence N-2°14'W, 2246.5' to a point, Thence S-88°48'W, 2471.0' to the point of beginning. The above being known as "MOUNT BALDY ESTATES - UNIT-1."

Beg. at the N.E. Cor., Sec. 4, T-13, R-3E as the true point of Beg. - Thence S-88°48'W, 2161.0' to a point, Thence S-0°35'E, 3584.0' to a point, Thence S-61°40'W, 449.10' to a point, Thence S-53°25'W, 1151.0' to a point, Thence S-69°40'W, 861.0' to a point, Thence S-0°10'W, 2386.60' to the point of beginning. The above being known as "MOUNT BALDY ESTATES UNIT-2."
